#### ORDER

**Subject: Appeal made by Shri. Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.**

#### **Facts of the Case:**

Shri Praveen Sakhuja vide his letter dated 9 January 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 10 November 2014.

Vide his RTI application dated 10 November 2014; Shri Praveen Sakhuja had sought the information regarding appointment of Wasi Azgar, AD(T) at EIA – Delhi.

The applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 9 January 2015 stating that CPIO has not provided the information as requested.

CPIO, EIA - Delhi vide their letter 15 December 2014 has provided the information requested at S.No. 1 of the application, to applicant. However, the letter does not mention about the information requested at S.No. 2 of the application.

The CPIO, EIA – Delhi is directed to provide the information requested by applicant at S.No.2 of his application dated 10 November, 2014 within 15 days of this order without any cost.
