**Subject: Appeal made by Mohammed Mushtaq Khan under Section 19 (1) of the Right to Information Act 2005.**

#### **Facts of the Case:**

Mohammed Mushtaq Khan vide his letter dated 31 January 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 31 December 2014.

Vide his RTI application dated 31 December 2014; Mohammed Mushtaq Khan had sought information regarding expenditures incurred/claimed by CMD and Director of EIC.

CPIO, EIC-Delhi vide letter dated 7 January 2015 provided the information to applicant.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 31 January 2015.

The applicant, in his appeal, has requested to provide the information as requested in his RTI application.

CPIO have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append.

Having gone through the appeal and information provided by CPIO, EIC, I am of the considered view that the request of applicant is addressed by providing the information. However, CPIO, EIC has not provided any information as requested at s. no. 6 of RTI application and has sought clarification, which is provided by applicant in his appeal letter dated 31 January, 2015.

#### **Orders:**

CPIO, EIC is directed to revisit the application and provide the information as requested at s.no. 6 of RTI application dated 31 December 2014 within 10 days of receipt of this order.

This disposes off the appeal of Mohammed Mushtaq Khan.
