ORDER

Subject: Appeal made by Sh. Rajiv Raizada under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Rajiv Raizada vide his letter dated 27 January 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 5 January 2015.

Vide his RTI application dated 5 January 2015; Shri Rajiv Raizada had sought information regarding details of gratuity, PF and leave encashment paid to the officers of EIC/EIA.

CPIO, EIC-Delhi vide letter dated 8 January 2015 provided the information to applicant.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 27 January 2015.

The applicant, in his appeal, has requested to provide the information as requested in his RTI application.

CPIO have preferred not to raise any comment on the appeal of the applicant as they have already clarified and they state that they have nothing to append.

Orders:

I find no infirmity in the reply of CPIO, EIC-Delhi and therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Shri Rajiv Raizada.
