Subject: Appeal made by Sh. Rajiv Raizada under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Rajiv Raizada vide his letter dated 23 February 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 21 January 2015.

Vide his RTI application dated 21 January 2015; Shri Rajiv Raizada had sought information regarding copy of file noting held in respect of sanction of retirement benefits to the applicant as Additional Director, EIC.

CPIO, EIC vide letter dated 09 February 2015 provided the information to applicant.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 23 February 2015.


The applicant, in his appeal, has requested to provide the information as requested in his RTI application.

CPIO have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append.

Orders:

I find no infirmity in the reply of CPIO, EIC and therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Shri Rajiv Raizada.
