ORDER

Subject: Appeal made by Sh. Rajiv Raizada under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Sh. Rajiv Raizada vide his letter dated 13 April 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 27 January 2015.

Vide his RTI application dated 27 January 2015; Sh. Rajiv Raizada had sought the information regarding pension details and option filed by some of the employees who has retired from EIA-Kochi.

CPIO, EIA-Kochi vide letter dated 18 February 2015 has informed the applicant that information sought pertain to personal details of employees and hence same is denied under section 19(1) of RTI Act.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19-(1) of the Right to Information Act 2005 vide his letter dated 13 April 2015.

The applicant, in his appeal, has requested to provide the information as requested.

CPIO, EIA-Kochi have preferred not to raise any comment on the appeal of the applicant as they have already informed the applicant and they state that they have nothing to append.

Orders:

I find no infirmity in the reply of CPIO, EIA-Kochi and therefore dispose the appeal without any further directions to CPIO, EIA-Kochi.

This disposes off the appeal of Sh. Rajiv Raizada.
