ORDER

Subject: Appeal made by Sh. V.N Narayanan Nair under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Sh. V.N Narayanan Nair vide his letter dated 11 May 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 18 March 2015.

Vide his RTI application dated 18 March 2015; Sh. V.N Narayanan Nair had sought the information regarding officials of EIA-Kochi who have en-cashed earned leave at the time of retirement after surrendering the leave en-cashed during 1.1.1986 to 3.1.1994 by adjustment from available leave.

CPIO, EIA-Kochi vide letter dated 17 April 2015 has informed the applicant that information sought pertain to personal details of employees and hence same is denied under Clause 8(1)(j) of the RTI Act.

Aggrieved by the reply of CPIO, EIA-Kochi the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 11 May 2015.


The applicant, in his appeal, has requested to provide the information as requested.
