**Subject:** Appeal made by Sh. Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.

#### Facts of the Case:

Sh. Praveen Sakhuja vide his letter dated 25<sup>th</sup> June 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 20<sup>th</sup> May 2015.

Vide his RTI application dated 20<sup>th</sup> May 2015; Shri Praveen Sakhuja had sought the information regarding Publication in Mail Today regarding suspension of Senior Govt. Official.

CPIO, EIC vide letter dated 16<sup>th</sup> June 2015 provided the information to applicant.

However, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 25<sup>th</sup> June 2015 stating that CPIO has not provided the complete information as requested.

CPIO, EIC has stated that information requested by applicant is already provided vide letter dated 16<sup>th</sup> June 2015 and preferred not to raise any comment on the appeal of the applicant and they state that they have nothing to append.

#### Orders:

I find no infirmity in the reply of CPIO, EIC and therefore dispose the appeal without any further directions to CPIO, EIC.
