Subject: Appeal made by Sh. Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Sh. Praveen Sakhuja vide his letter dated 25th June 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 20th May 2015.

Vide his RTI application dated 20th May 2015; Shri Praveen Sakhuja had sought the information regarding details related to appointment of Shri Kshitij Mishra, Assistant Director, his Qualification and Experience.

CPIO, EIC vide letter dated 2nd July 2015, 16th June 2015 & 22nd June 2015 provided the information to applicant.


However, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 25th June 2015 stating that CPIO has failed to provide the complete information as requested.

CPIO, EIC has stated that information requested by applicant is already provided vide letter dated 2nd July 2015, 16th June 2015 & 22nd June 2015 and preferred not to raise any comment on the appeal of the applicant and they state that they have nothing to append.

Orders:

I find no infirmity in the reply of CPIO, EIC and therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Sh. Praveen Sakhuja.
