**Subject: Appeal made by Shri M. T Babu under Section 19 (1) of the Right to Information Act 2005.**

#### Facts of the Case:

Shri M. T Babu vide his letter dated 22 June 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 23 April 2015.

Vide his RTI application dated 23 April 2015; Shri M.T Babu had sought the information regarding payment of pension granted to him.

CPIO, EIC vide letter dated 15 May 2015 provided the information to applicant.

Aggrieved by the reply of CPIO, EIC the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 22 June 2015.

The applicant, in his appeal, has requested to provide the information as requested.

CPIO, EIC has informed that word "not" has been in advertently missed at point no.2 of his RTI reply letter dated 15<sup>th</sup> May 2015 and has requested that point no.2 of RTI reply letter dated 15<sup>th</sup> May 2015 may be read as "The applicant is seeking confirmation on some calculations and requested for correction which does **not** qualify as information under section 2(f) of RTI Act."

CPIO, EIC have preferred not to raise any further comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append.

#### Orders:

I find no infirmity in the reply of CPIO, EIC and therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Shri. M.T Babu.
