ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 20 July 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 30 May 2015.

Vide his RTI application dated 30 May 2015; Shri Praveen Sakhuja had sought the information regarding Details on agreement with Event Management Company, souvenir procured etc.

CPIO, EIC-Delhi vide letter dated 30 June 2015 provided the information to applicant.
