ORDER

Subject: Appeal made by Shri. Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 20 July 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 22 June 2015.

Vide his RTI application dated 22 June 2015; Shri Praveen Sakhuja had sought the information regarding Address of EIC HQ at Kolkata and date of shifting to Delhi.
