ORDER

Subject: Appeal made by Shri Atul Kumar Ojha under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Atul Kumar Ojha vide his letter dated 7 July 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 21 May 2015.

Vide his RTI application dated 21 May 2015; Shri Atul Kumar Ojha had sought the information regarding details for the post of Office Assistant, Post Code – 1112/8.

CPIO, EIC vide letter dated 26 June 2015 provided the information to applicant.

Aggrieved by the reply of CPIO, EIC the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 7 July 2015.
