ORDER

Subject: Appeal made by Md, Zia-ul-Haque under Section 19 (1) of the Right to Information Act, 2005.

Facts of the Case:

CPIO, EIC have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append.

Having gone through the appeal and reply submitted by CPIO, EIC, I am of the view that there is no denial or concealment of information in this regard by CPIO and the request of applicant have been addressed by providing the information.
