ORDER

Subject: Appeal made by Shri. Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 8 December 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 28 November 2014.

Vide his RTI application dated 28 November 2014; Shri Praveen Sakhuja had sought information regarding 37th Session of Codex Alimentarius Commission (CAC) at Geneva, Switzerland during 14-18 July 2014.

CPIO, EIC vide his letter dated 3rd & 15th December 2014 provided the information to applicant.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 8 December 2014.

The applicant, in his appeal, has requested to provide the information regarding copy of tour programmes, approval of Competent Authority for travel and receipts for foreign exchange .

CPIO, EIC have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append.

Having gone through the appeal and reply submitted by CPIO, EIC, I am of the view that applicant has filed similar application in the past for which the information and copies of required documents have been provided. There is no denial or concealment of information in this regard by CPIO and the request of applicant have been addressed by providing the information.


Orders:
