ORDER

Subject: Appeal made by Sh. M T Babu under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Sh. M T Babu vide his letter dated 7 June 2016 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 4 April 2016.

Vide his RTI application dated 4 April 2016; Sh. M. T Babu had sought the information regarding delay in payment of sanctioned pension benefits.

CPIO, EIC vide letter dated 9 May 2016 provided the information to applicant.

Aggrieved by the reply of CPIO, EIC the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 7 June, 2016.

The applicant, in his appeal, has requested to provide the complete information.

CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to applicant and they state that they have nothing to append.
