#### ORDER

**Subject: Appeal made by Sh. Rajiv Raizada under Section 19 (1) of the Right to Information Act 2005.**

#### **Facts of the Case:**

Sh. Rajiv Raizada vide his letter dated 18 June 2016 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 23 March 2015.

Vide his RTI application dated 23 March 2015; Sh. Rajiv Raizada had sought the information regarding name and designation of employees of EIA-Mumbai whose retirement benefits were settled during January 2014 to March 2015.

It has been informed by applicant that his RTI application has been refused to be accept by EIA-Mumbai. Aggrieved by the refusal by EIA-Mumbai the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 18 June, 2016.

CPIO, EIA-Mumbai has informed that they have not refused to accept any RTI application.

The applicant has now appealed to provide the information as per his RTI application dated 23.03.2015.

#### **Orders:**

It is observed that the appeal is preferred in this RTI is time barred and ideally should be rejected on this ground itself. However, looking into the spirit of this RTI, CPIO, EIA-Mumbai is directed to provide the information as per provision of RTI Act 2005 and also to ascertain the reasons for refusal of RTI as claimed by the applicant.

This disposes off the appeal of Sh. Rajiv Raizada.
