**Subject: Appeal made by Shri Sabyasachi Banerjee under Section 19 (1) of the Right to Information Act 2005.**

### Facts of the Case:

Shri Sabyasachi Banerjee vide his letter dated 03 December 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 10 September 2015.

Vide his RTI application dated 10 September 2015; Shri Sabyasachi Banerjee had sought the information regarding disbursement of pension fund through LIC and approval in Council meeting.

CPIO, EIC vide letter dated 5 October 2015 & 3 November 2015 provided the information to applicant.

Aggrieved by the reply of CPIO, EIC the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 3 December 2015.

The applicant, in his appeal, has requested to provide the complete documents.


CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to applicant and they state that they have nothing to append.
