Subject: Appeal made by Sh. Rajiv Raizada under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Sh. Rajiv Raizada vide his letter dated 05 July 2016 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 11 April 2015.

Vide his RTI application dated 11 April 2015; Sh. Rajiv Raizada had sought the information regarding pension & GPF Scheme.

CPIO, EIA-Kochi vide letter dated 7 May 2015 informed the applicant that the information contained in the Service Book of an official is essentially personal in nature and disclosure of such information is exempted under Section 8(1)(j) of the RTI Act, since it would not serve any larger public interest.

Aggrieved by the reply of CPIO, EIA-Kochi the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 05 July, 2016.

The applicant, in his appeal, has requested to provide the complete information.

CPIO, EIA-Kochi has preferred not to raise any comment on the appeal of the applicant as they have already informed the applicant and they state that they have nothing to append.


Orders:

It is observed that the appeal preferred in this RTI is time barred and ideally should be rejected on this ground itself. However, looking into the spirit of RTI Act, appeal of applicant is admitted.

I find no infirmity in the reply of CPIO, EIA-Kochi and therefore dispose the appeal without any further directions to CPIO, EIA-Kochi.

This disposes off the appeal of Sh. Rajiv Raizada.
