ORDER

Subject: Appeal made by Sh. Rajiv Raizada under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Sh. Rajiv Raizada vide his letter dated 27 December 2016 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 5 July 2016.

Vide his RTI application dated 5 July 2016; Sh. Rajiv Raizada had sought the copies of form 16 for the financial year 2004-05 to 2009-10.

CPIO, EIA-Chennai vide letter dated 11 November 2016 stated that they are in process of searching the old records vide letter dated 24.01.2017 informed the applicant that as per office procedure, the Original Form – 16 was handed over to respective employee and no separate Form 16 are maintained at this office and hence not available.

Aggrieved by the reply of CPIO, EIA-Chennai the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 27 December, 2016.

The applicant, in his appeal, has requested to provide the copies of Form 16 as requested

CPIO, EIA-Chennai has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to applicant and they state that they have nothing to append.

Orders:

I find no infirmity in the reply of CPIO, EIA-Chennai and therefore dispose the appeal without any further directions to CPIO, EIA-Chennai.

This disposes off the appeal of Sh. Rajiv Raizada.
