ORDER

Subject: Appeal made by Shri V.N Narayanan Nair under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri V.N Narayanan Nair vide his letter dated 03.02.2017, received on 07.02.2017 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 21.12.2016.

Vide his RTI application dated 21.12.2016; Shri V.N Narayanan Nair had sought the information regarding leave surrender benefit of employees who have retired from EIA-Kochi.

CPIO, EIA-Kochi vide letter dated 20.01.2017 has informed the applicant that information sought pertain to personal details and hence same is denied under Clause 8(1)(j) of the RTI Act.

Aggrieved by the reply of CPIO, EIA-Kochi the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 03.02.2017 received on 07.02.2017.

The applicant, in his appeal, has requested to provide the complete information.


CPIO, EIA-Kochi has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to applicant and they state that they have nothing to append.

Orders:

I find no infirmity in the reply of CPIO, EIA-Kochi and therefore dispose the appeal without any further directions to CPIO, EIA-Kochi.

This disposes off the appeal of Shri V.N Narayanan Nair.
