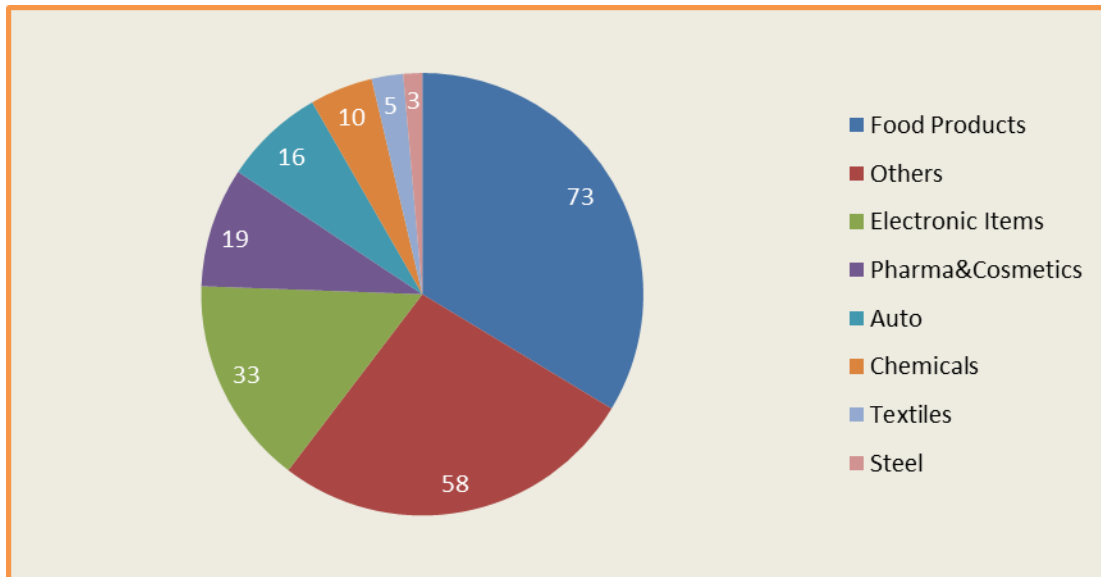

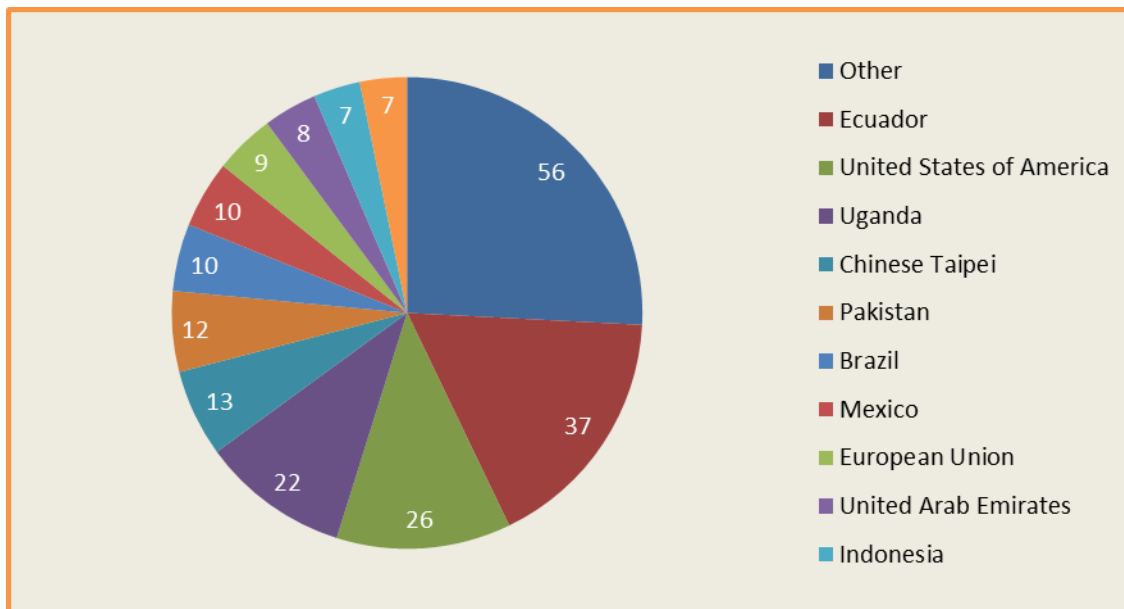

Notification Details:

The total numbers of TBT Notifications issued by the various WTO-Member Countries in January 2015 were 217. Out of 217 notifications, 61 notifications were the adoption of draft regulations notified earlier in the WTO.

Product-wise Information: Out of the total 217 Notifications, 73 were related to food products, 19 related to pharmaceutical and cosmetics products, 16 related to Auto products, 33 related to electrical products, 10 related to chemicals, five related to textiles, three related to iron and steel products the remaining 58 notifications were related to other products.

Country-wise Information: Out of the total 217 notifications, Ecuador issued 37 notifications, followed by United States of America, Uganda, Chinese Taipei, Pakistan, Brazil, Mexico, European Union, and UAE with 26, 22, 13, 12, 10, 10, 9, 8, 7 and seven notifications, respectively. The remaining 56 Notifications were from other WTO Member countries.

Request for relevant Regulations/translated copies sent to the issuing countries:

We have sent request for regulations for 38 notifications. The responses were received from Taiwan and United Arab Emirates. However, the responses from the rest of the countries are awaited.
