

**ORDER**

**Subject: Appeal made by Shri Praveen Sakhuja, Delhi under Section 19(1) of the Right to Information Act, 2005 – RTI Application No. EIA-Delhi / EIA-2018-006 – reg.**

**Facts of the Case:**

Shri Praveen Sakhuja, Delhi vide his application dated 29<sup>th</sup> November, 2018 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his RTI application request dated 15<sup>th</sup> October, 2018.

Vide his RTI application dated 15<sup>th</sup> October, 2018, Shri Praveen Sakhuja, Delhi had sought the information regarding certified copies of issuance of 06 CoO under AIFTA to M/s Talent International, Moradabad in June/July, 2018 on IR basis.

CPIO, EIC vide reply dated 15<sup>th</sup> November, 2018, has informed the applicant that “the information sought includes details of the CoOs issued to an exporter, therefore, information sought cannot be provided as per section 8(1)(e) of RTI Act 2005”.

Aggrieved by the reply of CPIO, EIC, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act, 2005 vide his application dated 29<sup>th</sup> November, 2018.

The applicant, in his appeal, has requested for certified copies of the file noting, records of matter regarding issuance of CoO to M/s Talent International after lapse of 12 months.

CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already informed the applicant that information cannot be provided as per section 8(1)(e) of RTI Act, 2005 and they state that they have nothing to append.

**Orders:**

The applicant is already informed by CPIO, EIC that information cannot be provided as per section 8(1)(e) of RTI Act, 2005.

This disposes off the appeal of Shri Praveen Sakhuja.
