Sir,


As you are aware that the establishments processing Fish and Fisheries Products are approved and monitored as per Govt. of India Order and Notification No S.O. 729(E) and S.O. 730(E) respectively, both dated 21st Aug 1995.

Further as per the FSS ACT 2006 every food business operator in the country needs to take either registration or licence as per applicability under the said Act. Since there is duplication of inspection, the matter regarding waving off inspections of Food Business Operator (FBO) by FSSAI was taken up by EIC with FSSAI. FSSAI in principle has agreed to wave off the inspections, if the FBO is already approved by EIA's.

In view of above, I am directed to inform you that, Inspection reports of approved fish and fisheries products establishments by EIC may be sent to concerned Designated Officer (DO) of FSSAI as per the area of jurisdiction. List of Designated Officers (DO) is enclosed for ready reference, further on the strength of the inspection reports of EIA, FSSAI shall grant the licences to FBO.

In order to speed up the matter, SO's may be advised to send inspection reports directly to DO under intimation to HO and EIC.

Subject: Waiving of Inspection to FBOs with valid registration under EIC-regarding

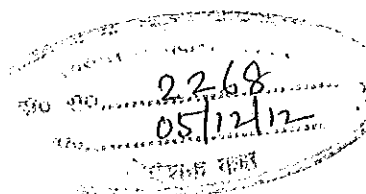
It has been communicated vide O.M. no. 03-01/2012/Enf-I/FSSAI dated 15-10-2012 to all the Designated Officers that 100% EOU's may be considered for grant of license under FSS Act, 2006 without inspection on the basis of inspection reports made available by the Export Inspection Agency (EIA). In line with this, Food Business Operator like Sea-Food Exporters who hold valid Registrations under Export Inspection Council of India (EIC) may also be considered to be granted Licenses without inspection based on the inspection reports made available by Export Inspection Agency. This arrangement is being accepted temporarily for time being in the interest of administrative exigencies.

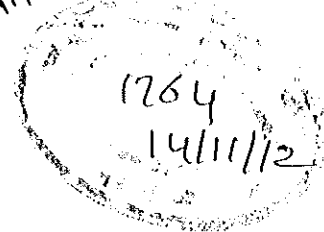

Regarding.**

A communication has been received in this Authority from Export Inspection Council of India (EIC), New Delhi proposing that establishments which are approved and monitored by it through Export Inspection Agencies (EIA) may be exempted from registration by FSSAI or such establishments may be granted registration on the basis of the approval issued by respective EIAs. This had been examined in the Authority and since it was observed that the inspection formats used by EIAs are similar to Schedule IV under 'FSS (Licensing and Registration) Rules, 2011', it is decided that Central Licences shall be issued to 100% Export Oriented Units (EoU) by the respective Designated Officers based on the Inspection Reports in the prescribed format made available by EIAs. This arrangement is being agreed for the time being in the interest of administrative exigency.
