### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja vide his letter dated 29.08.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 21.08.2013 of CPIO, EIC in relation to information sought by him vide his application dated 18.07.2013.

Vide his application-dated 18.07.2013 submitted through EIA - Delhi; Shri Praveen Sakhuja had sought copies of travelling details mentioned in log book of staff car used by EIC for ferrying Director for dates 10.07.2011 to 20.07.2011 and 10.08.2011 to 20.08.2011. In response, vide letter dated 21.08.2013; he was informed by the CPIO, EIC that the concerned division / section is not able to trace the records. The present appeal has been preferred by Shri Sakhuja as he considers that the records cannot go untraceable as few pages from the same were furnished to him by the CPIO vide letter dated 23.05.2013.

The appeal filed by Shri Praveen Sakhuja stands disposed of with the direction to CPIO, EIC to re-visit his application dated 18.07.2013 and either provide the information or inform the latest status to Shri Sakhuja within 2 weeks of this order.
