ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 20.05.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 18.03.2013 of CPIO, EIC in relation to information sought by him vide his application dated 13.02.2013.

Citing two replies given by CPIO, EIC on two different occasions, Shri Sakhuja vide his application dated 13.02.2013 had requested for (i) confirmation as to which reply was correct and (ii) copies of file notings held between CPIO and concerned divisions based on which two different replies were given. In response, the CPIO had informed Shri Sakhuja that (i) did not qualify to be information and that no file notings were held for (ii). Shri Sakhuja was also informed that Director, EIC had recommended reconsideration of 1st stage advice to CVC. Not satisfied with the reply, Shri Sakhuja has filed the present appeal.

I have gone through the appeal and observe that a CPIO is required to provide information that exists on record and that 'confirm which statement is true' involves interpretation, which is not a responsibility of the CPIO. As the available information has been furnished to him, the appeal made by Shri Praveen Sakhuja stands disposed of.
