### ORDER


**Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja vide his letter dated 21.06.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against reply dated 13.06.2013 of CPIO, EIC in relation to information sought by him vide his application dated 15.05.2013.

Vide his application-dated 15.05.2013, Shri Praveen Sakhuja had requested for seven information relating to employees of EIC & the five EIAs whose absence had been treated as dies – non in last 9 years (2010 – 2011 to 2012 – 2013 and preceding five years). In response, the CPIO had provided available information to Shri Sakhuja vide his letter dated 13.06.2013.

I have gone through the appeal filed by Shri Sakhuja and the case papers and observe (i) that Shri Sakhuja is habitual in filing applications in a large number on any matter, (ii) that Shri Sakhuja was not specific while seeking information and (iii) that searching such information from the records of last 9 years would seriously divert the resources of both EIC & the five EIAs in terms of Section 7(9) of the RTI Act.

As there is no denial of information, the appeal filed by Shri Sakhuja stands disposed of. Shri Sakhuja is also advised to be precise while seeking information in future and not to misuse his Right to Information as a tool for harassing the organisation.
