
Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 26.03.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against reply - dated 04.02.2013 of CPIO, EIA-Delhi in relation to information sought by him vide his application dated 10.01.2013.

Vide his application-dated 10.01.2013, Shri Sakhuja had sought a copy of recording of CCTV camera number 01 & 05 for period 08.01.2013 to 10.01.2013 from 0930 hours to 1230 hours. In case recording was not available, the CPIO was required to furnish two information relating to the recorder. While the second part of his application was addressed by the CPIO vide letter dated 04.02.2013, vide letter dated 19.02.2013, CPIO had informed Shri Sakhuja that the CCTV was installed for internal security and as such its recording cannot be provided. The present appeal has been preferred by Shri Sakhuja as he considers the ground for denial as 'flimsy'.

I have gone through the appeal filed by Shri Sakhuja and observe that (i) Shri Sakhuja is habitual of filing applications in a large number on almost any matter and (ii) Shri Sakhuja has not been able to demonstrate the public interest the information sought will serve.

As there is no infirmity in the order passed by the CPIO, EIA - Delhi, the appeal filed by Shri Sakhuja stands disposed of.
