
### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja vide his letter dated 04.07.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against reply dated 30.05.2013 of CPIO, EIC in relation to information sought by him vide his application dated 02.05.2013.

Vide his application-dated 02.05.2013, Shri Praveen Sakhuja had requested for two types of information relating to recruitments made from 01.01.2010 onwards (number of posts advertised for general & reserved categories and copy of caste certificate submitted by each candidate) for EIC & the five EIAs. In response, the CPIO had provided the web link where the information regarding the number of posts advertised was available and informed Shri Sakhuja that copies of caste certificates could not be provided in terms of section 11, 8(1)(e) and 8(1)(j) of the RTI Act. The present appeal has been preferred by Shri Sakhuja against denial of copies of caste certificates.

I have gone through the appeal filed by Shri Sakhuja and observe (i) that Shri Sakhuja is habitual in filing applications in a large number on any matter, (ii) that Shri Sakhuja was not specific while seeking information relating to caste certificates and (iii) that searching such information from the records of last 3 years would seriously divert the resources of both EIC & the five EIAs in terms of Section 7(9) of the RTI Act. As there is no denial of information, the appeal filed by Shri Sakhuja therefore stands disposed of.
