
Subject: Appeal made by Shri Praveen Sakhujia under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhujia vide his letter dated 16.04.2012 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against against letter dated 10.04.2012 of CPIO, EIC in relation to information sought by him at serial 4 of his application dated 28.02.2012.

Vide serial 4 of his application-dated 28.02.2012, Shri Praveen Sakhujia had asked for details of leave taken by Shri AC Dutta, including the period of leave and the destination to which he proceeded. In response, Shri Sakhujia was informed of the earned leave taken by Shri Dutta on five occasions including the period of leave. Shri Sakhujia has filed present appeal claiming that he has not been informed of the destination of every leave proceeded.

I have gone through the appeal made by Shri Sakhujia and observe that destination to which an employee proceeds on leave is a personal information, which does not serve any public activity or interest. Moreover, the organisation has no means of knowing where an employee proceeded on leave.

I do not therefore find any merit in intervening with the orders of the CPIO and the appeal filed by Shri Sakhujia stands disposed off.
