
ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 16.04.2012 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against against letter dated 10.04.2012 of CPIO, EIC in relation to information sought by him in his application dated 28.02.2012.

Vide his application-dated 28.02.2012, Shri Praveen Sakhuja had asked for 2 information in respect of leave taken by Shri Rajiv Raizada, Additional Director, EIC, namely (i) details of leave applications filed during the period 01.01.2011 to 31.12.2011 and (ii) copies of the above leave applications. In response, Shri Sakhuja was informed of the period of CL and EL availed by Shri Raizada. Copies of leave applications were denied in terms of section 8 (1) (j) of the RTI Act. Shri Sakhuja has filed present appeal demanding that CPIO be directed to provide copies of leave applications to him.

I have gone through the appeal made by Shri Sakhuja and observe that all information having any relationship to any public activity or interest was furnished by the CPIO. I therefore do not find any justification for further directions to CPIO and the appeal filed by Shri Sakhuja stands disposed off.
