ORDER

Subject: Appeal made by Shri Shiv Prakash Saxena under Section 19 (1) of the Right to Information Act, 2005

Shri Shiv Prakash Saxena vide his letter dated 02.03.2013 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 20.02.2013 of CPIO, EIC in relation to information sought by him vide his application dated 23.01.2013.

Vide his letter-dated 23.01.2013, Shri Saxena had sought 10 information related to special voluntary retirement scheme introduced in May 1994 for the employees of EIC & the EIAs. In response, Shri Saxena was informed by the CPIO, vide his letter dated 20.02.2013, that he was rather probing for information, that the information was very old and searching for it would involve diversion of resources of the organisation in terms of section 7 (9) of the RTI Act. Shri Saxena has filed the present appeal citing section 8(3) of the RTI Act.

I have gone through the appeal filed by Shri Saxena and observe that Shri Saxena has asked for information identified with other public authorities, was not specific while seeking information and has sought information that is pretty old. Accordingly I find no reasons to disagree with the CPIO. The appeal filed by Shri Saxena therefore stands disposed of.
