### ORDER


**Subject: Appeal made by Shri Shiv Prakash Saxena under Section 19 (1) of the Right to Information Act, 2005**

Shri Shiv Prakash Saxena vide his letter dated 24.02.2013 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 08.02.2013 of CPIO, EIC in relation to information sought by him vide his application dated 15.01.2013.

Information sought by Shri Saxena vide his application-dated 15.01.2013 and information furnished by CPIO, EIC vide his letter dated 08.02.2013 was as under:

Sl.	Information sought by Shiv Prakash Saxena	Information given by CPIO
1.	Copy of proposal initiated by Director (I&Q/C) in the year 1991 proposing voluntary retirement scheme, along with notings of MoC&I officials till 1994.	EIC is not able to trace information, as it is 22 year old.
2.	Copy of GoI notification / memorandum issued by MoC&I on VRS introduced on 21.05.1994 in EIC/EIA.	Not pertaining to EIC - may be sought from concerned public authority.
3.	Copy of notification / memorandum issued by DoPT or MoC&I for dealing with surplus staff of EIC/EIA.	Does not pertain to EIC.
4.	Notification of GoI that EIC is a statutory body under MoC&I.	No information on record.
5.	Copy of memorandum / order of MoC&I for retrenchment scheme for surplus staff of Jute scheme of EIA - Calcutta in the year 1991.	Information sought is vague.
6.	Copy of orders / directions issued by MoC&I in the year 1991 for the CPF employees who had completed 5 years of service.	Information sought is vague.
7.	Whether Director (I&Q/C) had acted under the Export (QC&I) Act 1963 while introducing VRS.	Seeking interpretation-does not qualify as information under RTI Act.

As Shri Saxena asked for interpretation, sought information that is pretty old and was not specific while seeking the information, I do not find any infirmity in the order of the CPIO, the appeal filed by Shri Saxena stands disposed of. Information sought at 2 above was produced at this stage and a copy of the same is attached (letter no. 3 / 8 / 91 - EI & EP dated 21<sup>st</sup> May 1994).
