ORDER


Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 01.04.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 25.03.2013 of CPIO, EIC in relation to information sought by him vide his application dated 26.02.2013.

Vide his letter dated 26.02.2013, Shri Praveen Sakhuja had sought three information namely (i) *Number of sub-offices working without a permanent head (in-charge of office)* in each of the five EIAs, including their location, (ii) the date from which these offices were working *without a permanent in-charge* and (iii) the number of offices where in-charge was due to retire in the month of March till June 2013. In reply vide his letter dated 25.3.2013, the CPIO, EIC had furnished the required information except for the dates from which the sub-offices were working *without permanent in-charge*.

Shri Sakhuja has filed the present appeal stating that the information namely the (a) dates from which the sub-offices were working *without permanent in-charge* (ref: ii above) and (b) names of offices where in-charge was due to retire in the month of March till June 2013 (ref: iii above) have been deliberately concealed by the CPIO.

I have gone through the appeal filed by and observe that whereas CPIO has not furnished information at (ii) above, at (iii) above, Shri Sakhuja had asked for the "numbers" which was duly furnished by the CPIO. Accordingly, the CPIO, EIC is hereby directed to inform Shri Sakhuja, within two weeks of receipt of this order, the dates from which sub-office Agra and Kanpur are working *without permanent in-charge*.
