#### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja vide his letter dated 08.04.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 03.04.2013 of CPIO, EIC in relation to information sought by him vide his application dated 08.03.2013.

Information sought by Shri Praveen Sakhuja vide his letter dated 08.03.2013 and furnished by CPIO vide his letter dated 03.04.2013 were as under:


Shri Sakhuja has filed the present appeal, claiming the following in respect of the above.

- Copy of joining report to be provided.
- Copy of tour programme & settled TA bills to be provided.
- Number of official national visits till 08.03.2013 to be provided.
- f to h. Information to be provided after obtaining it from the concerned Agency / Director.

I have gone through the appeal filed by Shri Sakhuja and observe that a CPIO is obliged to furnish information that serves some public interest and is available on records, without causing unwarranted invasion of privacy of an individual. Accordingly, I uphold the action of the CPIO in not furnishing to Shri Sakhuja the copies of the documents demanded by him. Further, I do not find any infirmity in the order passed by the CPIO in respect of queries listed at 'f' to 'h'. At the same time, Shri Sakhuja is entitled to the following information, which the CPIO – EIC is directed to furnish to him within 2 weeks of receipt of this order.

1. Copy of tour program of the 1<sup>st</sup> official air travel undertaken by Dr. S. K. Saxena after joining EIC as Director;
2. Number of official national visits of Dr. Saxena during the period 05.02.2012 to 08.03.2013;
3. Within 2 above, class in which air travel was under taken; and
4. Amount spent by EIC on each travel detailed at 2 above.
