ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005


Shri Praveen Sakhuja vide his letter dated 08.04.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 02.04.2013 of CPIO, EIC in relation to information sought by him vide his application dated 05.03.2013.

Vide his letter dated 05.03.2013, Shri Praveen Sakhuja had sought six information in relation to certain visits undertaken by Director, EIC by staff car. His present appeal arises out of the following queries raised by him in his application dated 05.03.2013 and the related reply given by the CPIO.

Sl.	Information Sought	Reply by CPIO
b.	Purpose of his visit to those States, stating name of the States	Two State(s) / UT(s) i.e. Uttar Pradesh and Chandigarh
f.	Amount of petrol and cost spent on each visit as mentioned above.	Expenses on each visit are not available

I have gone through the appeal filed by Shri Sakhuja and observe that (i) the purpose of the visits is contained in the documents demanded by him against serial 'e' of his application - furnished by the CPIO vide letter dated 14.05.2013 and (ii) a CPIO can only supply such information that exists on records.

As the available information has been furnished by the CPIO, the appeal made by Shri Praveen Sakhuja stands disposed of.
