**Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja vide his letter dated 20.05.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 09.05.2013 of CPIO, EIC in relation to information sought by him vide his application dated 14.03.2013.


The present appeal by Shri Sakhuja arises out of the reply given by the CPIO vide his letter dated 09.05.2013 to the queries raised in his application dated 14.03.2013 at 'a', 'b', 'f', 'g' and 'h'.
