Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 20.05.2013 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against CPIO, EIC for not providing information sought by him vide his application dated 18.03.2013.

On enquiry, it has been stated by the CPIO, EIC that the information could not be furnished as the same was not made available by EIC / EIAs.

The explanation given by the CPIO, EIC is not acceptable. The CPIO, EIC is therefore directed to process the application-dated 18.03.2013 of Shri Sakhuja as per rules within 15 days of this order.
