### ORDER


**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja vide his letter dated 20.05.2013 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against CPIO, EIC for not providing information sought by him vide his application dated 25.03.2013.

On enquiry, it has been stated by the CPIO, EIC that the information could not be furnished as the same was not made available by concerned section.
