
ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 20.05.2013 (received on 23.05.2013) has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against CPIO, EIC for not providing the information sought by him vide his application dated 08.04.2013.

On enquiry, it has been informed by the CPIO that the information sought vide application-dated 08.04.2013 concerning reply dated 5th April 2013 of the CPIO was furnished to Shri Praveen Sakhuja vide letter dated 28.05.2013 (copy enclosed). Shri Sakhuja may also note that at times, the information received by CPIO (based on which information is furnished to the applicant) is of confidential nature, which cannot be made available to the RTI applicants.

As there is no denial of information, the appeal filed by Shri Sakhuja stands disposed of.


