ORDER


Subject: Appeal made by Shri P. Chidambaram under Section 19 (1) of the Right to Information Act, 2005.

Shri Chidambaram vide his letter dated 20.03.2011 (received on 01.04.2011) has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against order dated 03.03.2011 of CPIO, EIC in respect of information sought by him vide his application dated 07.02.2011.

Vide his letter-dated 07.02.2011; Shri Chidambaram had requested to know whether MoC&I has the statutory authority to float a Voluntary Retirement Scheme (VRS) and whether VRS floated by MoC&I vide ref. No. 3/8/91-EI&EP dated 21.05.1994 and 2/1/2002-EI&EP had been approved by the Department of Personnel & Training / Department of Pension & Pensioner's Welfare. In response, the CPIO, EIC vide his letter dated 03.03.2011 had informed that the information sought was not available on the records of EIC.

I have gone through the appeal of Shri Chidambaram as well as the reply of the CPIO, EIC and observe that whereas there is no denial of information, the CPIO, EIC ought to have referred the request of the applicant to the CPIO, MoC&I, as the information sought by the applicant pertained to the Ministry.

The appeal made by Shri Chidambaram is accordingly disposed off.
