
Subject: 3rd Appeal under Section 19(1) of the Right to Information Act, 2005 -- reg.

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 18.03.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 16.01.2013 of CPIO, EIC in relation to information sought by him vide his application dated 17.12.2012.

Vide his application-dated 17.12.2012 filed with EIA - Delhi, Shri Praveen Sakhuja had sought inspection of file noting / records / advices / opinions / reports held by the concerned authority from date of initiation of inquiry against him till conclusion to impose penalty. The application was forwarded to CPIO, EIC who in turn had denied the request of Shri Sakhuja citing Section 8(1)(h) of RTI Act 2005.

I have gone through the appeal filed by Shri Sakhuja and the case papers and observe that even though the penalty has been imposed, channels of appeal / review by Appellate / Reviewing Authority and challenge before the judicial forum have not yet been exhausted and therefore, the process cannot be said to be over and the information sought by the applicant cannot be parted with. I have also observed that Shri Sakhuja is habitual in filing applications in a large number on any matter thus misusing his Right to Information.

As there is no firmity in the order passed by the CPIO, EIC, the appeal filed by Shri Praveen Sakhuja stands disposed of
