
### ORDER

**Subject: Appeal made by Shri Vinay Kumar under Section 19 (1) of the Right to Information Act, 2005.**

Shri Vinay Kumar vide his letter dated 17.06.2010 (received in this office on 27.06.2011) has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 07.06.2011 issued by CPIO, EIC in relation to information sought by him vide his letter dated 04.05.2011.

Vide his letter-dated 04.05.2011, Shri Kumar had requested for 20 items of information and while providing information in respect of point no. 7 to 20, the CPIO had informed him that information in respect of point no. 1 to 6 could not be provided as process of recruitment was not yet complete. Shri Kumar has contested this statement of the CPIO by pointing out that the names of candidates selected for the post of AD (NT) and Sr. AO have already been loaded on the website.

I have gone through the appeal and the explanation given by the CPIO and observe that the event quoted by Shri Kumar is the declaration of the list of candidates recommended by the selection committee and that the process of recruitment is not yet complete. As I do not find any infirmity in the order of the CPIO, the appeal made by Shri Vinay Kumar stands disposed off.
