

**ORDER**


**Subject: Appeal made by Shri Parveen Kumar under Section 19 (1) of the Right to Information Act, 2005.**

Shri Parveen Kumar vide his letter dated 13.12.2010 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 07.12.2010 issued by CPIO, EIC in relation to information sought by him vide his letter dated 11.11.2010.

Vide his letter-dated 11.11.2010, Shri Kumar had requested for inspection of all files of DPC proceedings of all posts held in the year 2008 for grant of ACP. In response, the CPIO, EIC had denied the information under the plea that applicant had already filed a case in the Hon'ble High Court of Delhi.

Whereas the reason given by the CPIO, EIC is not acceptable, as the information cannot be denied under Section 8 of the RTI Act unless so directed by the Hon'ble Court, inspection of the files can not be allowed as they will have to be collected from EIAs as well - diverting the work of the office. Further, these files contain confidential information about other officials, which can not be disclosed to the applicant.

In view of the foregoing, the appeal of Shri Parveen Kumar stands disposed off.
