### ORDER

**Subject:** Appeal made by Shri B. C. Saxena under Section 19 (1) of the Right to Information Act, 2005.

Shri B. C. Saxena vide his letter dated 26.07.2011 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against the decision dated 18.07.2011 of CPIO, EIA – Delhi for not providing complete information requested by him vide his application dated 20.06.2011.

Vide his application-dated 20.06.2011, Shri Saxena had requested for following information:

1. Certified copy of notification containing amendment in RR for the post of Deputy Director (A&A).
2. Certified copies of appointment letter and all promotion orders issued in favour of Shri Parameswaram.
3. Certified copy of order where Shri Parameswaram has been appointed as Deputy Director (A&A).
4. Certified copy of delegation of power of the authority who has appointed Shri Parameswaram as Deputy Director (A&A).


I have gone through the records and observe that there is no employee by the name of "Parameswaram" in EIA – Delhi. However, as there has not been any objection from Shri Saxena for receiving information relating to "Parameswaran" instead of "Parameswaram", it is presumed that Shri Saxena was primarily interested in information related to "Parameswaran".

I also observe that following information was also furnished by the CPIO, EIA – Delhi to Shri Saxena.

1. That in respect of 1 & 4 above, A&A stands for the work related to Administration & Account,
2. Copies of documents listed at 2 above,
3. Copy of document listed at 3 above, and

I have gone through the appeal of Shri Saxena and the reply of the CPIO, EIA – Delhi and observe that all required information except the delegation that allowed assignment of work of administration & accounts to Shri Parameswaran has been furnished by CPIO, EIA – Delhi to Shri Saxena.

The CPIO, EIC, is therefore directed to provide Shri Saxena, within 15 days of receipt of this order, a copy of the delegation that allowed assignment of work of administration & accounts to Shri Parameswaran.
