### ORDER

**Subject: Appeal made by Shri Parveen Kumar under Section 19 (1) of the Right to Information Act, 2005.**

Vide his letter-dated 21.10.2010, Shri Parveen Kumar had requested for copy of records containing the information that the DPC held on 08.06.2007 had followed benchmark of two very good and no average. He had also requested for inspection of files in respect of the above. In response, CPIO – EIC vide letter no. EIC / D (Q/C) / RTI / 2010 / 6271 dated 28.02.2011 had informed Shri Parveen Kumar that there was no record demonstrating that DPC had followed the benchmark of two very good and no average. A copy of this letter was once again supplied to Shri Parveen Kumar on 05.08.2011 in response to Order dated 19.07.2011 of the CIC in case no. CIC/SS/C/2011/000318.

Shri Parveen Kumar has now filed 2<sup>nd</sup> appeal dated 25.08.2011, stating that CPIO – EIC has concealed the facts and falsified the information and has demanded that the CPIO – EIC be directed to allow inspection of files requested by him vide his letter-dated 21.10.2010. I have gone through the file and observe that there is no record to support that DPC had followed the benchmark of two very good and no average. As far as inspection of files is concerned, the same cannot be allowed as it contains confidential information in respect of other officials, which cannot be disclosed to Shri Parveen Kumar.

As there is no denial of information, the appeal of Shri Parveen Kumar stands disposed off without any direction to CPIO – EIC.
