
ORDER

Subject: Appeal made by Shri Parveen Kumar under Section 19 (1) of the Right to Information Act, 2005.

Vide his letter-dated 18.10.2010, Shri Parveen Kumar had requested for information in respect of 4 questions related to DPC conducted in the month of February 2010 for the post of Assistant Director (Technical). In addition, Shri Parveen Kumar had also asked for inspection of related files. The information in respect of 4 questions raised by Shri Parveen Kumar was furnished by the CPIO – EIC vide letter no. EIC/D(Q/C)/RTI/2010/6269 dated 28.02.2011. A copy of this letter was once again supplied to Shri Parveen Kumar on 05.08.2011 in response to Order dated 19.07.2011 of the CIC in case no. CIC/SS/C/2011/000316.

Shri Parveen Kumar has now filed 2nd appeal dated 25.08.2011, demanding that the CPIO – EIC be directed to allow inspection of files requested by him vide his letter-dated 18.10.2010. I have gone through the papers and observe that CPIO – EIC had provided him the information in respect of all four questions raised by him. As far as inspection of files are concerned, the same can not be allowed as they contain confidential information in respect of other officials, which can not be disclosed to Shri Parveen Kumar.

As all required information has been provided, I do not find any reasons to give any directions to CPIO – EIC and the appeal of Shri Parveen Kumar stands disposed off.
