**Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005**


Shri Praveen Sakhuja vide his letter dated 05.08.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against CPIO, EIC for not providing information sought by him vide his application dated 03.06.2013.

Vide his application-dated 03.06.2013 filed with EIA – Delhi, Shri Praveen Sakhuja had desired to know (i) dates on which he was directed to attend medical board in last 10 years and (ii) how many other employees have been asked to appear before a medical board including the reasons thereof. Shri Sakhuja had also requested for copies of letters issued by EIC and the medical reports issued by the hospital concerned.

In the above context, Shri Rajvinder Singh, Deputy Director I/C, EIA – Delhi is hereby directed to provide Shri Sakhuja the date, if any, on which Shri Sakhuja was directed to attend medical board in the current year (2013), within 7 days of receipt of this order. Further, Shri Kannan Kasturi NS, DD (NT), posted at EIC is directed to provide Shri Sakhuja a copy of report of medical board to which Shri Sakhuja might have been referred to in the current year (2013), within 7 days of receipt of this order.

At the same time, Shri Sakhuja may please note that searching for the remaining 10-year-old information sought by him at (i) & (ii) above would disproportionately divert the meagre resources of the organisation in terms of section 7 (9) of the RTI Act. Also the copies of the documents sought by him cannot be supplied in terms of section 8(1)(h) of RTI Act 2005 as well as circular dated 04.04.2013 of CVC.

With the above direction, the appeal filed by Shri Sakhuja stands disposed of.
