
Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 01.04.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 in relation to information sought by him vide his application dated 08.03.2013.

Vide his application-dated 08.03.2013 filed with EIA-Delhi, Shri Praveen Sakhuja had sought information on nine points related to appointment of one Shri Inder Singh as an Inquiry Officer. While broadly informing Shri Sakhuja on 12.03.2013 that there was no information on records, the CPIO, EIA - Delhi had requested his counterpart in EIC to provide Shri Sakhuja the information in case the same was available with EIC. In turn, CPIO, EIC had provided Shri Sakhuja the date of appointment of Shri Inder Kumar as IO vide his letter dated 25.03.2013 while maintaining that the remaining information was not available on records.

I have gone through the appeal filed by Shri Sakhuja and the case papers and observe that the competent authority must have issued order appointing Shri Inder Kumar as IO and that the section dealing with administrative actions would have on their records the number of cases where Shri Inder Kumar was appointed as IO by the competent authority.

The CPIO, EIC is therefore directed to revisit point number 4 & 6 of application dated 08.03.2013 of Shri Sakhuja and provide him the information within 2 weeks of receipt of this order.
