
### ORDER

**Subject: Appeal made by Shri Kamal Kant Agarwal under Section 19 (1) of the Right to Information Act, 2005**

Shri Kamal Kant Agarwal vide his letter dated 26.08.2013 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against CPIO, EIC for not providing information sought by him vide his application dated 16.04.2013.

Vide his application-dated 16.04.2013 submitted at EIA – Delhi, Shri Agarwal had requested for nine information concerning recruitment of TO (one post reserved for PH, advertised in 2011) and AD (two posts reserved for ST, advertised in 2012). On enquiry, it has been stated by the CPIO, EIC that the information could not be furnished as the same was not made available by the concerned section.

The explanation given by the CPIO, EIC is not acceptable. The CPIO, EIC is therefore directed to process the application-dated 16.04.2013 of Shri Agarwal as per rules within 15 days of receipt of this order.
