ORDER

Subject: Appeal made by Shri Parveen Kumar under Section 19 (1) of the Right to Information Act, 2005.


Shri Parveen Kumar vide his letter dated 08.08.2013 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 27.05.2013 of CPIO, EIA - Delhi in relation to information sought by him vide his application dated 21.06.2013.

Information sought by Shri Parveen Kumar vide his application-dated 21.06.2013 and the reply of CPIO vide his letter dated 27.05.2013 (copy enclosed) were as under.

I have gone through the appeal of Shri Parveen Kumar and observe that the CPIO has already allowed inspection of records vide his letter dated 27.05.2013 (copy enclosed). As far as his query at 2 is concerned, it is vague and does not qualify as information under RTI.

The appeal filed by Shri Parveen Kumar stands disposed of with the advice that he should be precise while seeking information and that he should approach the Officer In-charge, Sub Office Agra, EIA - Delhi for inspection of records (relating to 1 above) at a mutually convenient date.
